Thank you for your interest in our e-Commerce services. Attached below is our Application Form & Subscriber Agreement Form for you to fill-up & sign as part of your registration process. These completed forms are required by our merchant banks and our headquarters in the United States.

Please do the following:

1. Print-out the Application Form (1 page) & Subscriber Agreement Form (1 page);
2. Fill-up all info and Sign both pages. Please complete Credit Card Number info, including the last 3 digits at the back of your card, and expiration date;
3. Attach a photocopy of:
 - a. Your Credit Card (front & back), as required by our bank to show card ownership,
 - b. The Credit Card Statement of Account, to verify billing address AND;
 - c. Your Photo I.D. (Driver's License or Passport), showing your signature and address;
4. You may Fax them to (63-2) 893.66.88 to immediately create your personal USA address;
5. You then send the original docs via FedEx, UPS, DHL, ABOITIZ, LBC or any courier to:

The *Local Tariff and Charges* are as follows:

You are given a FREE three (3)-month trial period, but there is minimum amount guarantee of One Thousand Five Hundred Pesos only. (Php 1,500) consumable within three (3)-months, non-refundable, as per our special promo. The only charges you will pay are the cost of shipments. For Air Freight Option, it will take 7-12 working days from the time your packages are received in Burlingame or in Miami to the time they arrive in our office for final pick-up by you or delivery to you. Via Sea Freight will take about 45-60 days.

The cost of Air-Freight using Burlingame (SFO) or Miami shipping facilities is USD\$ 0.25 per 10 Grams, while the cost of Sea-Freight is \$0.13 per 10 Grams, PRO-Rata. We will base the charges on the actual weight or the dimensional (volumetric) weight, whichever is higher, (no shipment no charges) PLUS customs/duties (IF ANY, when the contents of your packages are commercial in quantity and/or more than US\$500 in value). These rates are subject to change without prior written notice.

So if you wish to ship your packages by AIR, use our *Burlingame (SFO) or Miami address*, and if by SEA, our *Los Angeles address*.

After the free trial period of 3 months, you will automatically be subscribed to our Annual MAILBOX program by paying either 4,800 pesos per Year or 2,700 pesos per Half-year or 1,500 pesos per Quarter unless you give us written notice to terminate your account.

However, you can also subscribe to our NEW PRE-PAID program, with absolutely NO SUBSCRIPTION fee. The only charges you will pay are the cost of shipments. The cost of Air-freight is USD\$17.50 per 500 grams, while the cost of Sea-freight is USD\$8.75 per 500 grams.

We will base the charges on the actual weight or the dimensional (volumetric) weight, whichever is higher, (no shipment no charges) PLUS customs/duties (IF ANY, when the contents of your packages are commercial in quantity and/or more than USD\$500 in value). These rates are subject to change without prior written notice.

MyUSmailbox.com Subscriber Agreement

The MyUSmailbox.com service will be provided by Smart Mail Inc (Mail Boxes Etc-Salcedo hereinafter called MBE) & Island Internet Inc (SMI/III) both Philippine corporations. MBE/SMI/III will provide the MyUSmailbox.com subscriber with an address in the United States of America (“facility”) for his or her exclusive use, comprising a street address for the receipt of US mail and correspondence, packages, mail order merchandise (and enabling deliveries from US express carriers such as FedEx, DHL and UPS). It is the responsibility of the Subscriber to ensure that all remitter and correspondence are provided with the correct mailing address.

Subscriber agrees to comply with all applicable domestic and foreign laws and regulations, including those of the U.S. Subscriber acknowledges that he or she is prohibited from sending or receiving illegal materials or controlled substances such as drugs, explosive or hazardous materials. Subscriber is solely responsible for his mails & packages that pass through the MyUSmailbox.com facility and shall free MBE/SMI/III from any and all responsibilities & liabilities related to receiving, processing and forwarding any of the Subscriber’s Packages & Mails. Subscriber authorizes MBE/SMI/III to open and inspect contents of any packages/mails addressed to his/her MyUSmailbox.com account, and agrees that MBE/SMI/III will not be responsible for any losses incurred due to confiscation by any customs or government agency. Subscriber is solely responsible for any fines or penalties incurred. Subscriber is responsible for obtaining any import or export licenses required by any relevant country or territory. MBE/SMI/III will handle the receipt of all correspondence and packages at the US and will sort, consolidate, and transport these items to the Philippines. MBE/SMI/III will also handle customs clearance, but any customs duties and / or taxes owing are the sole responsibility of MyUSmailbox.com Subscriber.

Applicable transportation and other charges applicable to the Service plan chosen by Subscriber are outlined on the Schedule of Local Information and Tariffs (the Schedule), as amended from time to time, a copy of which Subscriber acknowledges receiving. Subscriber agrees to the terms set forth therein, agrees that prices and services are subject to change from time to time at the sole discretion of Mail Boxes Etc-Salcedo, Smart Mail Inc & Island Internet Inc (MBE/SMI/III) and agrees to pay all such charges incurred. Subscriber acknowledges that dimensional weight will apply on items when the dimensional weight is greater than the actual weight (as is standard practice for international transportation). Dimensional weight (in kilos) is charged when the result of multiplying the item’s height (in centimeters) by its length (in cm) by its width (in cm.), divided by 6000, is greater than the actual weight of the item.

Subscriber authorizes MBE/SMI/III to charge the credit card designated on the application form or any other credit card and info. that may be provided by the Subscriber in the future, for all charges incurred through use of the MyUSmailbox.com facility including subscription fees, customs duties, catalog and publications order processing charges and transportation charges (based on actual or dimensional weight, which ever is higher) in accordance with the MBE/SMI/III’s Philippine Schedule in effect. MBE/SMI/III will provide, without any additional charges than those set forth in the Schedule, declared value coverage for the declared customs value merchandise transported up to \$20 (Twenty Dollars). For declared customs value above \$20, the Subscriber shall be responsible to insure the additional declared value coverage and shall advise such insurance to MBE/SMI/III. Subscriber agrees to be bound by the terms and conditions for Declared Value Coverage set forth in the schedule of Local Information and Tariffs, as amended from time to time in SMI/III’s sole discretion. Subscriber acknowledges that all items including artwork, jewelry, glassware, negotiable instruments, will be limited to a maximum declared value of US \$20.

The street address will be subject to change, in the event MBE/SMI/III relocates its reception and processing facility. MBE/SMI/III would provide at least 60 days advance notice of any address change. It will be the responsibility of the Subscriber to ensure that all remitters and correspondents are provided with the correct mailing address using the personalized account code and to notify them of any address change in the event of facility relocation.

This Agreement will be in force for one year from the date of enrollment, and will be renewed automatically on an annual basis unless MBE/SMI/iii is notified in writing of Subscriber’s wish to terminate not later than 30 days prior to the renewal date. If Subscriber of MBE/SMI/III cancels service before expiration of this Agreement, any subscription fee already paid will not be prorated or refunded. This Agreement may be terminated by either party with 30 days prior written notice. During any such 30 days termination period MBE/SMI/III will have the option of returning all correspondence and packages to the senders or forwarding such to the subscriber under then-current billing terms or liquidate packages to recover overhead costs. Non-payment of charges incurred by Subscriber within 30 days from date of charge will automatically terminate this Agreement and cancel his US address facility. In case there are Subscriber’s mails/packages left in the US or Philippine office or warehouse due to cancellation/non-payment/no valid info, MBE/SMI/III will have the option of returning all correspondence and packages to the senders or dispose/sell/liquidate packages to recover overhead costs.

Signature of application form (Digital Signature when the “I Agree” button is pressed if done through the web site and/or internet), and/or activation by Subscriber of his MyUSmailbox.com facility by receiving any mail and packages will represent full acceptance of this agreement and authorization to charge the designated credit card(s) as outlined in this application and corresponding Schedule.
